4. Details of our assessment

The site was visited as part of the pre-season check on Cemaes designated bathing water.

Natural Resources Wales staff were accompanied by three Dwr Cymru staff including the area pollution technician and north west sewerage manager.

The Traeth Bach beach, the emergency outfall for this pumping station and the adjoining stream were checked for evidence of pollution in general and sewage derived debris in particular. No evidence of pollution was seen and no evidence that the emergency outfall had been used.

Dwr Cymru staff were queried regarding the condition of the sewer draining into the pumping station and when had it last been de-silted. This question was raised as a couple of manholes along the road had been known to discharge onto the road historically, but no reports had been received in the last few years. The sewerage manager followed this question up following the visit and confirmed that a CCTV survey had been done in 2023 and would enquire about a further survey.
