4. Details of our assessment

This report details the site visit made on the 10 April 2024 to Race Farm located at New Inn, Pontypool, Newport, NP4 0TP, permit number, EPR-GB3439DE.

Natural Resources Wales (NRW) Officer Greg GARDNER and Waste Regulation Higher Education Placement Cerys PHILLIPS attended Race Farm, New Inn to undertake an unannounced site inspection. The inspection took place at 10:00am where the weather was wet, and windy which it had also been the previous day.

GENERAL OBSERVATIONS

This was a follow up inspection to the one conducted on 18/08/21 (CAR_NRW0038642), to ascertain if any activities had or were taking place at Race Farm in relation to permit EPR-GB3439DE.

Upon arrival there was no waste(s) present and the site was completely clear (see photos 1-3). From the previous site inspection (CAR_NRW0038642), there were windrows of compost present however they have since been removed. There were no offensive odours and / or excessive noises present during the inspection. There was no on site plant / machinery present in the permitted area at the time of the site inspection. There was also no evidence of contamination or illegal waste activity such as fly-tipping and there were no waste(s) stored outside of the permitted boundary.

To confirm, based upon the type of permit and the subsequent inspection that is held as well as the activity that is / was held at this site, Race Farm, New Inn – (Permit Number - EPR-GB3439DE) this site would still be eligible for a low risk surrender however this would need to be determined / analysed by the NRW waste permitting team.
