Site visit was arranged to enable a review of Celsa's ongoing actions to control the flies in the scrap cans that are stored on site.

The weather conditions at the time of the visit were dry, cloudy, temperature was approx. 20 degrees Celcius, light wind. There had been earlier rain so the ground conditions were wet.

Scrap cans were still present on site (current inventory 10 800t). There are four separate stock piles, one of these is stored undercover in the Old Meltshop building. On the three external stockpiles there was very little evidence of fly activity, even after disturbing the surface layer of cans. Neither were there any flies in the general area. There was no evidence of flies associated with the stockpile stored under cover.

The fly traps on the boundary fence were being changed at weekly intervals. In the traps that were observed there was a layer of flies 2 to 5cm deep. There was no evidence of flies in the vicinity of the traps.

It was explained that spraying of the stockpiles was now planned to be carried out twice weekly until the situation was under control. The most recent spraying was completed yesterday. Celsa advised that the inventory reduction had been less than expected due to an extended unplanned outage last week. Yesterday, 20t of scrap cans per melt were trialled in the furnace but it was not yet known if this was going to be a usage rate that could be maintained. For the period since can use data had been reported the average rate of can use had been 12.3t/melt.

The general situation on site was clearly much improved, although it could not be determined if this was due to the weather conditions, or, a direct result of the actions carried out by Celsa. However, it remained important that Celsa continue with the agreed strategy.

Reports were still being received from local residents including this morning. It was possible that while the situation on Celsa's site had improved a high population of flies remained present across the locality and these were continuing to affect the local residents.

It was explained that NRW's enforcement response remained under consideration.
