In accordance with current NRW policy, only the first exceedance of an emission limit value in the reporting quarterly period is categorised as a non-compliance. No further non-compliances for the same species are recorded in the quarterly period. However, as noted above all scores for CO exceedances have been suspended pending a permit variation. Of particular note is that the EC BREF for Iron and Steel Making does not include an emission limit value for CO for Electric Arc Furnaces. So in the absence of any specific local air quality issues there is no ongoing justification for retention of a CO limit.
