### 4. Details of our assessment

Planned inspection of pumping station but self report from DCWW on the 14/02/2024 (15:51hrs) of a burst pipe downstream of pumping station with investigations ongoing to determine exact location. Ammonia samples taken by DCWW operatives with results below:

Surface Water Drain 0.64mg/l  
Downstream 0.04mg/l  
point of entry 0.00mg/l  
upstream 0.54mg/l.

Heavy rain during on site visit with DCWW on the 15/02/2024, crew in-situ to determine point of discharge entering surface water line underground. The manhole was sucked dry during our attendance to enable a camera survey to be undertaken. At the time of our visit DCWW were still unsure of the location of discharge from the pipe.

Pumping station visited. Significant overland flow from above the works down the hill/access track to the works which was reported to enter the chambers on site at times causing some flood incidents. During the inspection the overland flow was generally running upstream of the pumping station asset in the field and not causing an immediate issue.

Weir level asset set at 2.04L/s with DCWW operatives advising that approx. 6 L/s being passed forward under normal operations. However, DCWW received an alarm for the asset on the 7/2/2024 with a level reading of 16 L/s. this indicated a burst within the mains system. At the time of the visit 12.18 L/s being passed forward to the works.
