### 4. Details of our assessment

Compliance inspection undertaken by officers Harry Warburton, Hannah Jenkins and Alexander Grainger at St Nicholas STW on 13/03/2024 to assess permit AG0013201. The

weather at the time was dry.

St Nicholas STW is scheduled for improvements under AMP7. The site suffers heavily from surface water infiltration.

### **Inlet and primary tanks**

The inlet is unscreened and gravity fed, which then goes to the primary tank followed by copra sac screening after the primary tank.



### **Secondary treatment**

There is two large percolating filter beds which appeared in good order. The effluent then goes to another primary tank. Some effluent is pumped from here back to the inlet, this was said to help alleviate the site from some of the infiltration volumes. This second primary tank also had recently been installed with an ammonia trigger monitor due to some ammonia exceedances for the site.



After this there are some redundant sludge drying beds which were said to be removed under AMP7. There is then a final effluent sampling chamber and outfall. The outfall was accessed through a field next to the site. There didn't appear to be any adverse impacts on the watercourse downstream of the discharge.

- Provide evidence for work that has been done recently to improve the infiltration issue into the works and what investigations are planned.
- Provide information as to what is planned for the works under AMP7.
