4. Details of our assessment

Introduction

This CAR form has been issued in response to a report of an uncontrolled release of nickel carbonyl and carbon monoxide on 7 May 2023 at the Clydach Refinery. A Schedule 5 notification was subsequently submitted to Natural Resources Wales.

Gas Release

The operator reports that during the isolation process preceding a planned shutdown, a loss of containment of gas occurred in the site Kiln Plant.

During this process, Vale report that the isolation of nickel carbonyl and carbon monoxide return valves was incomplete and the pipework was open to atmosphere following the removal of a pipe spool. The fixed CO monitor and personal alarm of the operator were activated and the Kiln Plant was evacuated.

The volume of gas released was estimated by Vale to be approximately 10m³ with no indication from external or perimeter alarms that gas escaped beyond the Kiln Plant.

The investigation of the root cause of the incident by Vale has identified gaps in the procedure for isolations during planned shutdown of the Kiln Plant. The return valves have been brought into the scope of the isolation procedure, pipework has been modified to comply with the Health and Safety Executive guidance *HSG253 The safe isolation of plant and equipment*, including colour coding and locking arrangements.

Compliance

Permit condition 3.1.1 states there shall be no point source emissions to air except those listed in Schedule 3 of the permit. This breach has been assigned a non-compliance category of C3 under compliance criteria IR3A Emissions to water, air or land.

Further to the unpermitted point source emission, the root cause of this incident has also been considered. The omission of the return valves from the shutdown procedure and required remedial actions indicate a deficiency in the shutdown procedures as applied. This

is a breach of permit condition 1.1.1 in respect of operations and has been assigned a non-compliance category of C3 under compliance criteria IR1A General management.
