4. Details of our assessment

The purpose of this Compliance Assessment Report (CAR) is to acknowledge a Natural Resources Wales site visit to AB Connectors on the 19th March 2024.

Brigid Armstead and Dale Padfield from NRW met with Ian Tollan from AB Connectors. This visit was instigated for introductions due to a change in Site Officer on the Part of NRW. Brigid will be the primary contact for this site on behalf of NRW.

Business updates received included the expansion of the harness assembly area and significant drop in cadmium plating over the last few years which has recently stabilised.

NRW advised of upcoming BREF review which will lead to a permit variation being instigated.

Site tour included a walk around the assembly area, machine area, plating room, Effluent Treatment Plant and yard. No non-compliances were observed during the site tour.
