The request is asking if you require the entire Welsh inshore region. For example, could this be split into smaller areas to reduce to burden on our GIS proximity checking system.

It doesn't sound like this is possible and I will ask GIS to run the check on the North Wales Zone and we will process that SSL as previous. For the Mid and South Wales zones – it might be better to go down the route of normal SSL applications as and when the university will be surveying within these areas.

Good afternoon Ian,

Thank you for your SSL application. Can I confirm that there are no spatial changes between the previous licence areas and this licence application? We are unable to use the images provided in our conflict check but, if the survey area required is the same as SR_BgU_14, 15 and 16, we can use the previous shapefiles.

Looking at our records the current SSLs have the following expiry dates: SR_BgU_14 – expiry 22/11/23; SR_BgU_15 – expiry 18/01/24; SR_BgU_16 – expiry 22/02/24.

We will progress these as quickly as possible, but a renewal will not be possible within the typical six-week timeframe. I apologise for any inconvenience, but these are large spatial checks and will require a significant amount of time to review internally.
