Accessing from the Network Rail Access point at SH 73001 77383, operatives will make way to the site location, by foot within marked walking areas. the site team will be briefed prior to work commencing on tide times, emergency evacuation procedures and any site specific ecological requirements.

Should work be undertaken during the hours of darkness, our site team will utilise 18v battery powered task lighting to provide adequate lighting to all access/egress areas and work areas.

Operatives are to set up temporary exclusion zones around the work areas to minimise the risk of any public interaction, we will however supply signage to brief the general public on the works we are undertaking. this exclusion zone will be removed between shifts.

Operatives are to remove the existing, damaged D300 tidal flaps using hand tools where possible, if unable to, an 18v battery angle grinder will be used to remove the tidal flaps. Once removed from the sea defence, operatives will remove the Tidal flaps from site and dispose of at a licenced waste recycling centre.

Prior to the installation of the new D300 Tidal flaps, our skilled operatives will carry out any minor masonry repair to the sea defence, to ensure a flat, even surface to the proposed locations. this will be carried out using SIKA Parex Marine Mortar and site won material if required.

After curing time, the site team will install the new D300 Tidal flaps to the proposed locations, as per the manufacturers instructions, using Sika marine friendly sealants where required.
