4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of a Schedule 5 notification on 25th January 2024, by First Milk Cheese Company Ltd for activities at Haverfordwest Creamery, Pembroke Road, Merlin's Bridge, Haverfordwest, SA61 1JN under permit number EPR/XP3830UR.

First Milk submitted a Schedule 5 (Part A) notification to NRW on the 25th of January 2024, informing NRW of a permit breach. The notification outlined that on the 24th of January 2024, during the final stages of planned improvement works to the T51 drain area, a discharge of approximately 20-30 litres of potentially contaminated surface water was discharged onto the adjacent roadway, this discharge ceased after approx. 45 minutes. The discharge was contained by the kerbing and cleaned up promptly. A discharge also occurred at the W1 outfall. An estimated 150-200 litres of potentially contaminated surface water was discharged from the W1 outfall for a duration of approx. 2 hours. First Milk inspected the watercourse and observed 'no impact due to the trickle of liquid'.

The Schedule 5 (Part B) Notification was received on the 2nd of February 2024, which provided further detailed information on the incident and the action undertaken by the operator. The cause of the release was found to be due to a faulty seal on a 'Viking joint' within the surface water line. First Milk provided photographs of the incident location, roadway and watercourse. Immediate action included the sealing of the surface water line with the installation of a bung, diverting flow to the effluent treatment plant (ETP), and set up pumps in place as a back-up measure. The roadway was cleaned up on the day of the event and First Milk confirmed that no liquid had breached the kerb or made its way to any unmade ground. The measures taken to prevent recurrence were also outlined within the document. These included replacing the seal on the 'Viking joint', reviewing the frequency of inspections on the joint, and relining the surface water manhole, to be completed by 16/02/2024.

NRW later received confirmation from First Milk that the actions to seal the 'Viking joint' and to reline the surface water line had been successfully completed. No further issues noted.

The above activity constitutes a permit breach of permit condition 3.1.1 – *There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1 and S3.2.*

First Milk have been issued with a **Cat 3 non-compliance**, scored in line with CCS scoring guidance, for a breach of the emissions. Which has been scored against Compliance Criteria IR3A.
