3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

For clarity, this CAR has been carried out on the 19/04/2024 but is in relation to the routine monitoring sample that was taken on 04/04/2024.

The suspended solids result for the sample was 30.5mg/l compared to the permit limit of 30 mg/l. This is considered as a C4 - A non-compliance which has no potential environmental effect.

The results for ammonia and Biological Oxygen Demand (BOD) were very low and therefore this suggests that surface water may be entering the package plant.

A representative for the caravan park confirmed that a pipe serving the package plant had been broken as a result of construction on site a few days prior and that this may have been the pathway for surface water to enter the system.

Action: as discussed, apply for exemption to discharge to surface water for other package treatment plant on site and apply for a transfer/ new permit, in the name of the caravan park for the package treatment plant associated with BB3491FS. Please ensure that you have applied for both, no later than 31st May 2024.
