4. Details of our assessment

This report details the site visit made on the 27 March 2024 to Aberbargoed (Household Waste Recycling Centre) Permit EPR-RP3395FM. Officer Carla CURTIS attended site for a for an unannounced inspection at around 14:15. The weather conditions were sunny, windy and it had just been raining heavily.

GENERAL OBSERVATIONS

This site is used as a household waste transfer station with the waste being distributed to other companies and sites within the UK. The site was operational at the time of the visit with many vehicles entering and leaving the HWRC. No waste of any type was visible outside of the permit boundary.

WASTE ACTIVITIES

All waste storage containers were clearly marked, and signage was in place to inform members of the public what each bin contained. General housekeeping on site was of a good standard. All infrastructure appeared to be adequately working and maintained. (See image)



SITE SECURITY

The site has secure storage containers and also benefits from 24 hour CCTV monitoring.

TECHNICAL COMPETENCY

The current TCM for the site is Scott Jones. The WAMITAB certificate expires February 2026.

WASTE RETURN SUBMISSIONS

Waste returns for the site appear to be up to date and correct. The total quantity of waste accepted at this site must not exceed 24,999 tonnes per year. Based on the submitted waste return data for 2023, the total waste accepted was 4123.29 tonnes which is within the sites annual threshold.

No permit non-compliances were identified on this visit and thus no breaches have been scored.
