4. Details of our assessment

The purpose of this report is to:

- **assess and record compliance with the Emissions to Water conditions relating to Event Duration Monitoring**
- **give advice on complying with Condition 3.1.2 (a)(i) going forward.**

On the 22 March 2024 you sent to us a Trigger Exceedance Notification (TEN) for New Penclawdd PS CSO. The TEN informed us that, on the 29 February 2024 the number of spills had exceeded the limit of 26 block counted spills within a calendar year.

This permit has not been updated with the revised EDM permit conditions which require you to notify us of an exceedance within 4 weeks. However, the permit does require you to submit an initial report within 3 months of the exceedance as per Condition 3.1.2 a (i) shown below.

(a) If the measured number of block-counted significant spills exceeds the limit specified in Table S3.1 then the operator shall: i) **within 3 months of the trigger breach**, submit an initial report to Natural Resources Wales for approval, with reference to the Best Practice Guidance in Schedule 4 Table 4.2, and, where appropriate proposals, including timeframes, for a full investigation into the operation of the overflow including a timetable for the investigation.

As the Trigger was exceeded in 2023 as well, you have already provided us with an initial report which was submitted on the 2 November 2023. The investigation proposal was approved by us on the 21 November 2023 and was expected to be completed by the 30 April 2024.

In your investigation proposal you indicated that, once the investigation is completed, there may be a need to model the catchment using the information gathered.

Action: Please provide us with an update on your investigation into the operation of the overflow by the 31 May 2024. If you have found that further work is needed you should submit another initial report for our approval.
