4. Details of our assessment

Site Report

CAR form relating to a planned run to waste trial which occurred at 10:00 on 10/04/2024 at Maerdy WTW (Permit AF3002901). The operation conducted was compliant but currently not permitted as a variation of the licence is being processed. NRW were notified as agreed throughout the trial.

The run to waste trial operated from 10:00 until 13:30 (3.5hrs) at a flow rate of 70l/s. A total volume of 703m³ was discharged. Water was passed through a dechlorination chamber made up of dechlor baskets filled with dechlor pucks. Sampling took place at SS 97265 98835 every 15 minutes

with readings noted and photographic evidence submitted as part of the final OPNOT. Limits were set for total iron, pH, turbidity and total chlorine with no sample exceedances seen throughout the process. No breach was seen – no actions required.
