4. Details of our assessment

The Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) Regulating Officer to comment upon the Q1 Monitoring Returns.

Q1 Monitoring Returns

Q1 2024 (January - March) monitoring results were submitted to NRW on 02/04/24 in accordance with Condition 4.2.3.

Emissions to Water - Emission Point W1

Emissions to water for Q1 were tested on 31/01/2024, 15/02/2024 and 19/03/2024.

Biological Oxygen Demand (BOD) for January 2024 was recorded as 57.3mg/l, which exceeds the emission limit values (ELVs) of 40mg/l as defined in the Permit (S3.2). **This is in breach of Condition 3.1.2 and has been scored C3.**

A Schedule 5 Notification was submitted to NRW on the 15 February 2024 reporting the elevated BOD. The notification identified the likely root cause of the breach to be due to external contractors cleaning the drainage system and the subsequent identification of a collapsed drain. W1 was resampled on 15 February and scheduled for laboratory analysis. The analytical results were submitted to NRW on 22 February 2024 and reported all analytes, including BOD, to be below the ELVs. The Operator has received a quotation for the required repair of the collapsed drain.

ACTION: Drain repair to be completed by **30 June 2024**; confirmation of repair to be evidenced to NRW.

All other parameters were within the emission limit values (ELVs) defined in the Permit (S3.2).

Schedule 5 Notifications Parts A & B

A Schedule 5 Notification Part A & B was received on 20 February 2024 relating to an oil separation pipe burst on the 20 February 2024. The burst resulted in approx. 42kg of R448A (N40) being released. An engineering contractor (Border Temperature Controls) attended the site and replaced the pipe and refilled the condenser with 42kg of R448A.

The system was tested and approved for operation. The engineering contractor will continue to monitor the system for leaks and undertake preventative maintenance if needed.
