4. Details of our assessment

On 9th October 2023 Environment Officers Susan Lenthall and Edward Cox attended Goytre/Penperlleni WTW at 11:23.

On arrival, the weather was dry yet the storm tank contained a significant volume of sewage.

We were informed that the storm tank is emptied manually and this had last been carried out on 11/10/2023.

ACTION: Please ensure the storm tanks are checked and emptied as per the conditions in your new permit, issued shortly after this inspection.

You may wish to consider an automated system to prevent the risk of breaching permit conditions.

Overall, the site was clean and clear.

In conjunction with the inspection an audit of flow data from 21/11/2022 to 21/11/2023 was conducted. After reviewing the data there was no indication of breaches of the permit. Please note that a new permit has been issued 27/11/2023. Please continue to collect data and inform NRW in accordance with the new permit. Furthermore, the data provided indicated that the FFT information was non-MCert. It is a requirement of the new permit that MCert certification is needed for the data.
