**4. Details of our assessment****Q1 2024 (January - March) monitoring results were submitted to NRW on 3 April 2024 in accordance with Condition 4.2.3.**

Emission Point A1 Continuous air emissions monitoring (CEMS) was undertaken in accordance with Condition 3.2.

- No Half Hourly or Daily Average Environmental Limit Values (ELVs) for Hydrogen Chloride, Ammonia, Total Organic Carbon, Oxides of Nitrogen, Sulphur Dioxide, Nitrous Oxide and Particulates were exceeded during Q1 in accordance with Condition 3.2.1.
- Emissions to air (Emission Point A1) for Carbon Monoxide show no 10 minute (ELV 95th percentile) or Daily Average ELV exceedances in accordance with Condition 3.2.1.

Daily averages were not available due to the plant being off line for more than 2.5 hours in a calendar day on the following dates:

- 02/01/2024 and 03/01/2024 – plant off-line due to boiler expansion joint repair works
- 04/01/2024 to 06/01/2024 – plant off-line due to grate bar damage repair works.
- 08/01/2024 – plant off-line boiler trip due to high roof temperature, locking out feedwater pumps.
- 27/02/2024 to 29/02/2024 - plant off-line due to grate bar damage repair works.

Stack emissions monitoring was undertaken in accordance with Condition 3.6.1 during March 2024. All results were below the ELVs.

Residues Bottom Ash and Air Pollution Control residues sampling was undertaken in accordance with Condition 3.6.1. Bottom Ash composition for Q1 remained below the 3% TOC limit at 1.9% in accordance with Table S3.4 of the Permit.

Plant operating hours year to date; 2,042 hours were recorded with no periods of abnormal operations.

**Waste Returns.**

Waste returns have been provided for Q1 Waste Received Q1 – 54,330 tonnes, Waste Removed Q1 – 13,646 tonnes.

**Schedule Notifications.**

A Part A & B Schedule 5 Notification was received on 14 March 2024 relating to the opening of one of the boiler expansion flaps for one second. The Operator identified the root cause of the extension flap opening as likely being an unidentified gas bottle in the waste resulting in a rapid energy release inside the boiler. The consequence is the

triggering of the emergency safety feature resulting in the flap opening to reduce chamber pressure. The Operator undertakes regular waste inspections and targets any identified issues with suppliers to minimise the risk of such items entering the site.

No further actions are required following the Operators internal investigation.
