4. Details of our assessment

During a compliance inspection of Crynant WWTW on the 12th October 2023, NRW Officers observed that in an area to the South West of the site, directly adjacent to the

River Dulais a deposit of road sweepings had been made to land. This land sloped down towards the River Dulais and showed clear signs that when this deposit had been made, the liquid portion of the waste had run into the River Dulais. The waste appeared to have originated from within the site or at a similar site in that it was mainly comprised of silts, organic matter and a large amount of sewage rag. The roads and other hard paved areas at Crynant WWTW appeared to recently have been swept.

This is in contravention of the following condition:

General Management 1.1.1 (a) in accordance with a written management system that identifies and minimises risks of pollution so far as is reasonably practicable, including those risks arising from operations, maintenance, accidents, incidents, non-conformances and those drawn to the attention of the operator as a result of complaints.

The incident has been classified as Low level/Cat 3 for water quality.
