4. Details of our assessment

During a visit of the Spittal WWTW, the storm overflow weir was operating slightly at the time, despite the flow meter reading under the 4.4 l/s maximum flow rate. Only flows over 4.4 should be spilling to storm.

The operator explained that the bio-contactors can adequately cope with more flows, biologically and hydraulically, so it is planned to modify the inlet overflow weir to send more flows to be treated and reduce storm discharges. Infiltration is reported as a problem that exacerbates storm spills. Please supply a deadline for the weir modifications and, when done, confirm the work has been completed.

A permit variation may be required if pass-forward flow is being altered, however, this may be necessary to prevent the site from spilling to storm at flows less than the flow rate stated in this storm permit.

Update supplied 16 April 24 - Actions on CAR_NRW0043821 –

1. Modify storm spill weir to allow more flows to pass forward and prevent premature storm spills.

The modifications to raise the height of the storm weir were completed in February 2024 and have improved the assets flow performance.
