4. Details of our assessment

On 06/11/2023 and 14/11/2023, Natural Resources Wales received complaints regarding Plas Gwilym Quarry. The complaints stated that noise and vibration from the site were causing a nuisance.

Permit Conditions:

"3.3.1 Emissions from the activities shall be free from noise and vibration at levels likely to cause pollution outside the site, as perceived by an authorised officer of Natural Resources Wales, unless the operator has used appropriate measures, including, but not limited to, those specified in any approved noise and vibration management plan, to prevent or where that is not practicable, to minimise, the noise and vibration".

3.3.2 The operator shall:

(a) if notified by Natural Resources Wales that the activities are giving rise to pollution outside the site due to noise and vibration, submit to Natural Resources Wales for approval within the period specified, a noise and vibration management plan;

(b) implement the approved noise and vibration management plan, from the date of approval, unless otherwise agreed in writing by Natural Resources Wales".

Officers attended a location beyond the site boundary where noise pollution was witnessed leaving site, although not at levels which were deemed to be a nuisance.

The site is within close proximity to residential properties, which makes the site more sensitive in terms of noise and vibration pollution.

Due to recurring complaints, a Noise Management Plan was requested from the site over email on 14/11/2024.

A Noise Management Plan was provided by Danny Jones (Managing Director), on 06/02/2024. This document is currently in review by NRW.
