## 4. Details of our assessment

The purpose of report is to assess and record compliance with the Emissions to Water conditions relating to Event Duration Monitoring. On the 15 March 2024 you informed NRW by a Spill Frequency Trigger Exceedance Notification that there had been 25 spills. Condition 3.1.1 (Table S3.1) limits the spills from the asset at 14 in a calendar year.

I have assessed compliance with Condition 3.1.1 and found you to be compliant with this condition currently but you are required to ensure compliance with Condition 3.1.2 (a) as below:

(a). If the measured number of block-counted significant spills exceeds the limit specified in Table S3.1 then the operator shall:

- i) within 3 months of the trigger breach, submit an initial report to Natural Resources Wales for approval, with reference to the Best Practice Guidance in Schedule 4 Table 4.2, and, where appropriate proposals, including timeframes, for a full investigation into the operation of the overflow including a timetable for the investigation;
- ii) investigate the reasons for the exceedance in accordance with the approved investigation proposals and timescales;

(b) An exceedance of the adjusted number of spills limit shall not be recorded as a failure if the operator is meeting the requirements of conditions 3.1.2 (a) and 2.3.2.

The due date for this action is the 15 June 2024, which is 3 months from the date of the trigger exceedance Notification of 15 March 2024.
