4. Details of our assessment

This was a pre-planned audit carried out by Natural Resources Wales environment officers who were accompanied by a senior operative, pollution tech and performance manager from Dwr Cymru.

The weather was dry with rain experienced in the days leading up to the visit.

General Observations

Officers inspected the overflow at the inlet at Cynwyl Elfed WWTW. The discharge pipe was also inspected by officers.

The Process

The storm discharge comes from the inlet of the Cynwyl Elfed WWTW, this site has a separate discharge permit (BG0028101) and this is covered by a separate CAR form. There is an EDM monitor on the inlet that records when the storm overflow is operating. There is no screen on the storm overflow pipe at the inlet which is located before the macerator.

The storm flows then enter a covered concrete storm tank, there is no screen on the inlet or outlet

of the storm tank. Permit condition 2.3.2 (d) states; the shall not be macerated and shall have passed though screens as specified and shall not contain a significant quantity of solid matter with a particle size greater than any indicated (more that 6mm in 1 direction).

The discharge pipe for the Storm was snapped so the outfall was in the bank but not visible. The discharge point did not have any obvious odour and there was no fungus present.
