3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

Condition 3.1.2 (a) i) requires the following:

within 3 months of the trigger breach, submit an initial report to Natural Resources Wales for approval, with reference to the Best Practice Guidance in Schedule 4 Table 4.2, and, where appropriate proposals, including timeframes, for a full investigation into the operation of the overflow including a timetable for the investigation;

On the 02/06/2023 you sent to us a Trigger Exceedance Notification (TEN) for St Michaels Church CSO. The TEN informed us that, on the 08/05/2023 the number of spills had exceeded the limit of 14 block counted spills. CAR_NRW0042390 was completed and sent on the 06/09/2023 in respect of this breach. Following this CAR form a EDM TEN Initial investigation report was received by NRW on the 14/11/2023. The report stated that the recommendation at that stage was to:

- Repair the buried flow meter so that the pass forward flow penstock starts restricting the flow to the correct value,
- Continue to monitor the site and desilting when required to prevent build-up of debris.
- Link the investigations at both sites.
- Welsh Water aim to complete the investigation works by 1st May 2024.

On the 22/03/2024 NRW received a further Trigger Exceedance Notification (TEN) for St Michaels Church CSO. The report informed that on the 22/02/2024 the asset had again exceeded the limit of 14 block counted spills allowed within the permits conditions.

We await findings update from the investigation works at the asset and request a further report to confirm the outcomes.
