4. Details of our assessment

This is a follow up from CAR_NRW0042151.

For clarity, this CAR form refers to the operation of Event Duration Monitoring (EDM) equipment for this asset during 2022 but has been completed on the 29/04/2024

Condition 3.1.4 states that "The operator shall take appropriate measures to ensure that the event recorder remains fully operational at all times within the reference period specified in table S3.1. Any failures shall be remedied as soon as reasonably practicable".

The operational time for this asset was less than the minimum of 90%.

It was 56.48% operational and during this time there were 8 known spills.

Guidance for scoring the non-operational time suggests that this may have had a category 3 - a non-compliance that could have a minor impact on the environment.

DCWW were asked why this non-compliance occurred and what was done to resolve the issue(s).

The primary reason for the non-compliance was a communications failure/issue.

Site survey completed and confirmed that signal strength is poor at ground level. The aerial requires raising to improve reliability of data.

Please carry out improvements to increase the reliability of data and achieve minimum 90% EDM data reporting. Notify NRW that works have been completed, by the deadline.
