### 4. Details of our assessment

#### **FFRIDD RASUS LANDFILL SITE INSPECTION 25/04/24 @ 10:00hrs**

Following issues raised in previous CAR form number: **NRW0043445** regarding litter and general site management an inspection of required works and landfill gas flare/emissions was undertaken at the site on the above date.

#### **General Site Management**

Since the previous inspection on the 09/02/2024, a significant amount of work has been undertaken to remove bramble and other vegetation from the edge of area 2 (unlined landfill) to gain access to the embedded litter emanating from the operations in Area 1.

A team has now removed the majority of the litter and works to finish the clean up should be complete by the end of April.

The associated push wall storage for plastics has now been transferred indoors to prevent future escape of litter onto the adjacent landfill and the public footpath area outside the site.

#### **Gas Flare and Emissions**

The flare was inspected for regular flow and evidence of poor emissions/Maintenance. There was no evidence of inefficient combustion and gas flow to the flare was steady. There was no evidence of unburnt carbon/soot on the combustion chamber and temperature runs at a steady 1050 degrees Celsius, ensuring high combustion efficiency and low emissions.

#### **Sustainable Management of Natural Resources (SMNR)**

Site management will work with NRW and Kehoe Environment Services to ensure meadows at Ffridd Rasus and Llwyn Isaf are managed in a manner which promotes the development of maximum bio-diversity.
