4. Details of our assessment

NRW officers have attended at New Pines Caravan Holiday Home and Leisure Park on 8th March 2024 to carry out an inspection of Water Resource Permit WA/466/0007/003.

Officers have met site staff at the location and have been shown to the Water Abstraction point. The permit references the abstraction point at NGR SJ 03190 81661 although this is

not the current location of the abstraction point which has been re-located elsewhere on site.

Staff have made officers aware that no abstractions have been taking place on site for several years due to concerns with the water quality. Concerns are due to corrosion of component parts of the system thought to have been caused by the water. Whilst this is being investigated by the site, they have switched their water supply and are receiving water from Dwr Cymru/Welsh Water and have been doing so since ceasing abstraction.

It is requested from the permit holder that they provide a new NGR location for the abstraction point as this will need to be reflected on the permit held. This may incur a variation fee.

Additionally, the permit holder is required to record abstraction figures and provide annual readings to NRW. This can be done via the returns portal. Details to sign up to the portal will follow this report. It is appreciated that no abstractions have taken place for some time and this is likely the reason for no returns being provided, the permit does however require annual figures to be provided to NRW even if there is a nil return. These figures should be provided annually, no more than 28 days following the 31st March.
