3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Overall site and paperwork are good and well managed.

Biggest issue is maintenance of training certificates that demonstrate staff competency. Many are out of date and need to be updated. It would be good for the operator to review their H&S system as this issue was present on most of the sites visited.

Fallow period maintenance check-sheets were not fully signed off, making it hard to see what work had and had not been undertaken during the clean down process. Ensure contractors and all staff involved in the process are aware of the checklist and their requirement to sign off the work they carry out.

There were cracks in places but not in the main drainage channels. It would be good to get these repaired as they are still an access point for pollution and wash-water to reach the groundwater below. **This was also a non-compliance in the previous site visit as well.** Damaged and tired guttering was causing rain water to pool on the ground rather than enter the drains. While the site was stocking with fresh shavings, the water diverter was left open, potentially allowing wood shavings to enter the watercourse past the discharge point. Next to a surface water drain there was a split bulk bag of sand left open to the elements. This will be washed into the drains with the next rain.
