3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Overall site and paperwork are good and well managed.

Biggest issue is maintenance of training certificates that demonstrate staff competency. Many are out of date and need to be updated. It would be good for the operator to review their H&S system as this issue was present on most of the sites visited.

Missing waste transfer notes is an issue as there is no evidence of what has been moved off site as general waste. No waste transfer notes were on site since 2018.

On the whole, the concrete yard was in good condition. There were cracks in places but not in the main drainage channels. It would be good to get these repaired as they are still an access point for pollution and wash-water to reach the groundwater below. **This was also a non-compliance in the previous site visit as well.**
