### 4. Details of our assessment

On the 30th of April 2024 NRW Environment Officer Nathan Owen accompanied by SEO Cathrine Kiely visited the Cerrygydrudion WWTW and were accompanied by DCWW's NE Catchment Manager and Operations Supervisor.

On arrival at the site the primary tanks were being emptied by the DCWW contractors, the intake screen was in good condition.

The site contained x2 filter beds, which appeared to be well maintained with no visible signs of growth and the distribution arms in good condition, at the time of our visit the arms where not rotating however this was due to the primary tanks being emptied.

The final effluent chamber was in good condition with no sign of growth.

The site has seen significant investment recently with the addition of auto de sludge facilities and new EDM monitors being installed at the time of our visit to the site.

DCWW also informed that chemical dosing would also be added to the treatment works in the future.

NRW inspected the outfall of the work sand although the vantage point offered no clear view of the area there where no signs of any fungus wit the out in good condition.
