4. Details of our assessment

Annual Report 2023 received and reviewed.

Monitoring data

Surface water

Sampling point SWA was over compliance limits in both September and October. Breaches of pH, SS and NH3-N are considered minor non-compliances.

Leachate

Leachate levels in LW1, LW4, LW5, LW6, LW7 and LW8 were non-compliant during the course of 2023. However leachate levels have improved over the year with the increased levels being attributed to the well's location within the operational site and infrastructure pumping being suspended. Noted that the leachate treatment plant continues to run with similar volumes treated compared with last year. Permit breaches are considered minor non-compliances.

Sewer data

During this period 107,816 m³ of treated leachate was discharged to the sewer. All parameters were compliant.

Groundwater

Groundwater levels throughout 2023 are reported to show little variation. The slight level increase recorded towards the last quarter could be seasonal fluctuations. We have also discussed how groundwater levels could be influenced by the neighbouring quarry which have ceased groundwater extraction, and how this may need further investigation in order to understand the impact they may have on the site going forward.

In relation to groundwater quality, GW1, GW2 and GW12 have permit limits. Parameters were compliant during the reporting period. Site investigations have shown that GW5,

GW7, GW9, GW10, GW11 and GW13 currently have very low groundwater levels and slow recharge rates and therefore cannot be sampled. Refer to section 4 of Annual Report for further details.

Perimeter landfill gas

There were several exceedances of permit limits in perimeter borehole 22 during 2023. Boreholes 4 and 7 also exceeded limits. These breaches are considered a minor non-compliance.

Dust & PM10

Whilst PM10 results were compliant for the reporting period, deposited dust results from April show elevated levels of dust at station D3 (on the SE boundary) It has previously been raised that an off-site source may be contributing to deposited dust levels, PM10 levels were compliant at the same time of sampling.

Drawing title *Settlement January 23 -January 24 ref T3063101* received and reviewed.

Other items

Schedule 6 Notifications were also received separately for the above permit breaches. These have been reviewed, and considered as part of the site annual report.

Engine Emissions - monitoring data for 2023 received and reviewed. All parameters were compliant.

Validation Report for *Construction Of Sidewall Engineering 2023 Document Reference: BF5081/05/01 Nov 2023* received and reviewed. We are now satisfied with the proposal.

Review of complaints - one single complaint made in relation to the site during 2023.
