3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Annual Report 2023 received and reviewed.

Since 1st January, improvements made include:

1. Refurbishment of the perimeter gas borehole sample points to ensure adequate protection and safe access.
2. Refurbishment works to groundwater boreholes, including drilling of replacement boreholes where boreholes were no longer serviceable, providing improved access.
3. Works undertaken to improve pumping of leachate from the site, further maintenance undertaken to the leachate treatment plant, and installation of remote telematics, providing more consistent throughput.

Monitoring data

Surface water

Site reported that access to SW1 could not be obtained and issued no results throughout the period. Access to this point is required under the site permit. Site needs to attempt to restore this monitoring point, or provide an explanation why data cannot be obtained (**Action** – please refer to previous CAR forms) Breaches of BOD and NH3-N are considered minor non compliances.

Groundwater

Breaches of NH3-N are considered minor non compliances.

Perimeter landfill gas

The highest volumes of CH4 are detected within G4, G5, G6 and G7, located on the eastern perimeter of LWEE. All other monitoring points remain below permit limits.

Breaches of CH4 are considered a minor non compliance. We note separately that the values reported in G5 and G6 (up to 70.2% CH4) are not typical of landfill gas and may be

due to external influences, allowing ground gases to migrate through the local geology via a bedding plane or lens in the superficial deposits. This is currently being investigated.

Leachate levels

A reduction in leachate levels has improved and levels are now reported to be generally below the agreed compliance limit of 2m in LWS and LWEE. Single breach at MH5 considered a minor non compliance in first instance. Quarterly monitoring reports also include leachate quality, which has taken place in boreholes L2, L4, LTP1/MH4, SL4, SL5, SL6, SL7, SL8 and SL9. Additional points have been added. These include L1, L3, L5 and L6. **Action** - please provide leachate level data for these monitoring points where available (see table S4.1 of permit)

Topographical survey

Drawing title Settlement Levels 22-23 reviewed.

Separately, several Schedule 6 Notifications were received in 2023. These have been reviewed and considered as part of the site annual report.
