#### 4. Details of our assessment

This compliance assessment report (CAR) has been raised following a site meeting with the site management and North Wales Fire & Rescue Service (NWFRS) as a follow up visit from the fire incident that occurred on site on 18/03/2024.

The site provided an update into the investigations they have undertaken into improving the fire detection and suppression within the bio-drying tunnels.

The site has determined that a fully automatic sprinkler system would not be feasible or practical inside the drying tunnels but are looking at a manually activated system instead. Design plans will be submitted to NRW and NWFRS for comment prior to any work commencing.

Surveys have been completed on the tunnels and it will be possible to drill further holes in the tunnel roofs to install more temperature sensors and also use these in event of a fire in order for water to be directed down into the waste. During the incident NWFRS had difficulty accessing the area of the fire as it was so far down the tunnel and there is only one roller shutter door at the entrance.

The site will also install more CO2 monitors in the tunnels for the early detection of a fire. Once these new systems have been installed the FPMP will be updated and submitted to NRW.

All fire water run off from the fire was contained on site but there was a slight delay in getting tankers on site to remove the run-off and interceptors and drainage were at capacity when the first tanker arrived. The site has now implemented procedures to ensure if a similar incident were to occur in the future, tanker companies would be contacted as soon as possible to start removing fire water run-off. These procedures will be incorporated into the new version of the FPMP.

A press release was issued on 23/04/2024 by Wrexham County Borough Council about disposing of vapes, which contain lithium batteries, responsibly by disposing them as Waste Electrical and Electronic Equipment (WEEE) at household recycling centres not in waste bins or kerbside recycling containers.

A site tour was provided around the MBT areas and all was in order.
