The non-compliance listed above has been identified during our annual 2023 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions and Urban Waste Water conditions

3.3.7 The monitoring programme for the parameters subject to schedule 3C shall be:

- (a) pre-scheduled before each calendar year;
- (b) Unless otherwise agreed in writing by Natural Resources Wales, the operator shall submit the monitoring programme for the following calendar year to Natural Resources Wales before the 1st of December; and
- (c) samples must be collected at approximately equal intervals during the year from different days of the week and approximately 10% of samples should be taken at weekends.
