The non-compliance listed above was identified during our annual 2023 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions and Urban Waste Water conditions.

Please note: this CAR is dated 31/12/23 as these non-compliances relate to annual 2023 data, however for clarity I carried out the compliance assessment on 08/05/24

OSM 1 The Consent Holder shall, unless otherwise agreed in writing by the Agency, undertake a monitoring programme for the parameters specified by this consent which control the effluent quality by numeric limits, at not less than the frequencies specified in Annex T2 OSM2 to this permit.
