4. Details of our assessment

Site visited as part of routine compliance regulation work.

It's noted from the Rivers Trust website that the storm at this sewage works spilled 159 times in 2023 for 1694 hours. Is this correct? This equates to 70.6 days, or 19% of the year.

This site discharges upstream of Red Wharf Bay designated shellfish waters and Llanddona and Benllech designated bathing beaches.

Is any work underway, or planned to reduce the number of storm spills from this site e.g. by work in the catchment?
