You have confirmed that the proposed new hot water boiler at emission point A3 will be in operation for 8760 hours per year, and the fuel will be gas oil (diesel) You have confirmed that you will use the SCAIL combustion tool for assessing the impact from combustion plant on semi-natural areas like SSSIs and SACs:

Question 6 – Environmental Risk Assessment

Noise Management

As you have now confirmed that the proposed new MCP at emission point A3 will be operating continuously, you will need to update and resubmit your risk assessment. This is because your current risk assessment confirms that “the new hot water boiler is intended to be redundancy only”. We note that your Environmental Risk Assessment does make reference to a noise assessment modelling report for the proposed boiler. However this does not appear to have been provided.

Please reply within 10 working days from the date of this letter, quoting reference number PAN-023541. If we don't hear from you we must return your application and fee. When we receive the missing items we'll continue to check the details in your application. If there's enough there for us to begin the process of deciding whether or not we can grant your application we say the application is 'duly made' and we'll let you know this by letter/email.
