General Management - (W1A)

During the inspection officers requested copies of the permit, environmental management system (EMS) and records of site inspections.

The site inspection records and EMS were made available however the permit rule set were not locatable.

Action - as discussed on site, it is important that all members of staff have convenient access to the EMS and permit to aid in their duties.

Waste Operations - (W2A, W2C, W2D, W2E)

Activities and operating techniques being undertaken on site during the inspection were inline with those listed in **Table 2.1** of the permit.

Wastes identified in during the inspection were in line with **Table 2.2** of the permit all stored within separate identifiable containers.

Records - (W4A)

Records demonstrating compliance with the permit were available on site on request detailing daily staff inspections.
