4. Details of our assessment

The non-compliances listed above were identified during our annual 2023 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions and Urban Waste Water conditions (only applicable at some sewage treatment works).

Please note: this CAR is dated 31/12/23 as these non-compliances relate to annual 2023 data, however for clarity I carried out the compliance assessment on the 9th of May 2024.

P monitoring should be down for OSM monitoring, rather than included in the Urban Waste Water monitoring schedule. It's noted it's a composite sample that's recorded, which would be for Urban Waste.

As a consequence of the P error, there were more dates recorded on the schedule than required for UWWTD (4 required, 12 taken) and it is not possible to determine which were intended for UWWTD.

Please review your monitoring schedules / programme to prevent further similar issues.

A warning is issued as these scheduling issues have been discussed with Dwr Cymru over several years.
