### 4. Details of our assessment

Discussions have taken place between Natural Resources Wales and Dwr Cymru regarding an alleged no flow issue on the 19th of June 2023 regarding Discharge X and the evidence supplied to NRW.

A photograph supplied showed water flowing from the pipe, but Dwr Cymru argued that the flow meter showed no discharge and that the sample could not be taken without compromising the sample quality.

In light of the above we can only presume that Discharge X suffers from infiltration issues. Please investigate and deal with this issue.

Secondly, in light of your comments, please review the sample point set up and carry out remedial work as necessary so that samples can be taken without their quality being compromised.

Please keep us informed on progress with the required work.
