Form S1, Emissions to Sewer for 1st January to 31st March 2024 was received on 9th May 2024.

There are no emission limit values for emissions to sewer.

This report was submitted after the due date. Tradebe have put corrective actions in place and so a non-compliance has not been issued.

The report is accepted.

The permit variation, following publication of the BAT Conclusions for the waste treatment sector, introduced new monitoring requirements for Tradebe. The parameters to be measured from 17th August 2022 have not been finalised and so reporting requirements have not yet changed from those in the previous permit.
