Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

The non-compliances listed above were identified during our annual 2023 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions and Urban Waste Water conditions (only applicable at some sewage treatment works).

Please note: this CAR is dated 31/12/23 as these non-compliances relate to annual 2023 data, however for clarity I carried out the compliance assessment on the 10th of May 2024.

The non-compliances relate to a shortfall of two sampling shortfalls for Discharge X and one for Discharge Y.

Comments regarding fluvial flooding have been received from Dwr Cymru. In light of this, this CAR form is being issued for Advice and Guidance this time, rather than as a warning. However, please provide evidence that you have reviewed the sampling point location and looked for alternatives where fluvial flooding would not be an issue.
