4. Details of our assessment

The non-compliance listed above was identified during our annual 2023 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works

and water treatment works with Operator Self-Monitoring (OSM) conditions and Urban Wastewater conditions.

Please note: this CAR is dated 31/12/23 as these non-compliances relate to annual 2023 data, however for clarity I carried out the compliance assessment on 14/05/24.

Permit breaches

OSM 1 - monitoring shortfall - DCWW did not increase monitoring after the failure on the 19/07/2023 - shortfall of 4 samples in 2023.

OSM 11 - reporting exceedances - DCWW did not correctly notify NRW of the LuT failure - was notified as an exceedance instead.

Please explain the reasons for the permit breaches.
