4. Details of our assessment

The Fugitive Emissions Summary Report 2024 was received on 13th May 2024.

The report is accepted.

This report reviews ambient emissions of lead to air from the site. Ambient lead concentrations in air are measured at two locations and both show average annual concentrations less than the statutory air quality standard.

The condition of external bunds and the impermeable site surfacing have been assessed and either repaired as necessary or scheduled for repair during 2024.

This report demonstrates that the fugitive emission controls used by EnerSys are effective and that their environmental monitoring is suitable and sufficient.
