## 4. Details of our assessment

The non-compliance listed above was identified during our annual 2023 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions and Urban Waste Water conditions (only applicable at some sewage treatment works).

The non-compliance relates to permit condition:

3.3.7 The monitoring programme for the parameters subject to schedule 3C shall be:

(a) pre-scheduled before each calendar year.

The annual data audit identified the non-compliance as the scheduled sampling for Total Phosphorus 'P' for OSM was included on the UWW schedule in error. You first notified us of the non-compliance on the 22/02/2024. You told us that the non-compliance had happened as it had been added to the UWW schedule as it was taken as a composite sample. Programme reviewed for 2024 and removed.

We are aware that you have identified the root cause and have already taken actions to rectify the non-compliance.

It is an offence under Regulation 38 (2) of the Environmental Permitting Regulations 2016 for a person to fail to comply with or to contravene an environmental permit condition.

Please note: this CAR is dated 31/12/23 as these non-compliances relate to annual 2023 data, however for clarity I carried out the compliance assessment on 13/05/2024.
