Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

The non-compliance listed above was identified during our annual 2023 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self Monitoring (OSM) conditions and Urban

Waste Water conditions (only applicable at some sewage treatment works).

Please note: this CAR is dated 31/12/23 as these non-compliances relate to annual 2023 data, however for clarity I carried out the compliance assessment on the 13th of May 2024.

Phosphorus was not present on the initial annual sampling schedule for this site. This has since been reviewed and amended. Therefore this has been classified as a Category 4 Noncompliance against permit condition 3.3.7. This scoring is due to there being no potential impact to the receiving environment, as the schedule has been updated.
