Thank you for your response to the previous CARs form. Unfortunately it was slightly late so on this occasion we will be issuing advice and guidance. Could the following 2 points be clarified.

DCWW states that only 1 out of the 8 spills has been classed as significant. Could you provide data of the quantities spilled in each of these events as evidence to prove the claim that only 1 spill was significant. No data has been provided.

The reported number of spills (8) does not correspond with what was reported by DCWW In the annual returns where it says that the total number of significant spills for this asset is 10. Why is there a discrepancy between the number of spills reported. Could this please be explained?
