### 4. Details of our assessment

This CAR Form includes responses to the actions (deadline 12/01/24) from the last car form CAR\_NRW0043097. Thank you for providing a response.

**Action complete: Please clarify what the overflow weir is set at? and if there is a storm screen.** The overflow weir has been designed to spill the environment when the incoming sewer is receiving 120l/s. There is a storm screen in the CSO. At this moment in time the flow in the sewer network is not measured. Photo of the screen provided to NRW.

Data was requested following our site inspection. Data available: Inlet flow, Pass forward flow (PFF), Storm tank level and EDM spill from Roe Parc CSO. Using the data provided (pass forward flow and storm tank level), we have been able to calculate the flow in the sewer during a spill event from Roe Parc CSO. The flow

was 119l/s. Based on this and the small number of spills recorded for 2022 (2 spills) we are satisfied that the sewage treatment works and storm setting are operating as designed. However it is not clear from the permit how this is achieved. As the permit is due to be reviewed soon, to add further EDM monitors, NRW would like further clarification on the storm storage available, both online and offline, at St Asaph works. NRW permitting officers will be in touch as part of this process.
