4. Details of our assessment

On the 22/3/2023 OSM sampling was not able to be undertaken. "No flow" evidence has sluice plate shown as missing, therefore V notch bypassed. Operational issues meant that no sample was possible, but likely could have been. Oversight by the Operator who had left site and forgot to replace the sluice plate. The Work Manager for this area has taken a follow-up action to ensure that their team is diligently replacing

slides as soon as operational tasks are complete.
