and water treatment works with Operator Self Monitoring (OSM) conditions and Urban Waste Water conditions (only applicable at some sewage treatment works).
Please note: this CAR is dated 31/12/23 as these non-compliances relate to annual 2023 data, however for clarity I carried out the compliance assessment on 14th May 2024.

Dwr Cymru have rectified this issue for their 2024 sampling programme
